Cattaraugus County has allocated \$75,000 to support Thatcher Brook Flood Mitigation Project. A contract has been provided to the board so the Village can use those funds.

Authorization is needed to set up an investment account for Peter Cooper & Village Funds to help with the inflation factor while interest rates are high.

Motion 11-115-Motion by Trustee Zimmermann, seconded by Trustee Sisti to authorize the set up of an investment account for Peter Cooper and Village Fund. Motion carried.

The Village would like requests proposals for a big trash day in 2023.

Motion 11-116-Motion by Trustee Sheibley, seconded by Trustee Koch to request for proposals for big trash pick-up for the spring of 2023. Motion carried.

Budget Modification #2 was provided to the board for General and Water fund.

Motion 11-117-Motion by Trustee Koch, seconded by Trustee Sheibley to approve budget modification request #2. Motion carried.

Abstract bills to pay #6.

Motion 11-118-Motion by Trustee Sisti, seconded by Trustee Sheibley to approve the abstract bills to pay for General Fund \$37,067.37, Water Fund \$21,780.85, Sewer Fund \$47,271.31, Capital Projects \$20,955.00, and Community Development Special Projects \$14,500.00. Motion carried.
