An engineering services agreement with Mark Burr was provided to the board for approval for liaison services for the Point Peter Project which is FEMA reimbursable.

Treasurer-Traci Hopkins

The Point Peter pay #2 was provided to the board for approval.

Motion 5-201-Motion by Trustee Zimmermann, seconded by Trustee Sisti to approve the Point Peter pay app #2 for \$70,236.80. Motion carried.

The WWTP Capital Improvements Project Pay app #1 for STC Construction was provided to the board.

Motion 5-202-Motion by Trustee Koch, seconded by Trustee Sheibley to approve WWTP Capital Project STC Construction pay app #1. Motion carried.

Through all the funding sources for the WWTP Capital Project an updated agreement with Municipal Solutions for all the engineering, financial services. Phase I and Phase II agreements were provided to the board for approval.

Motion 5-203-Motion by Trustee Zimmermann, seconded by Trustee Sisti to approve the Municipal Solutions amended agreement for fees associated with WWTP Capital Project Phase I financing Requirements. Motion carried.

Motion 5-204-Motion by Trustee Sheibley, seconded by Trustee Sisti to approve Municipal Solutions amended agreement for fees associated with WWTP Capital Project Phase II financing requirements. Motion carried

Community Bank offers an ACH positive pay platform, a fraud control service that would service the Villages 4 main accounts-General, Water, Sewer, and Payroll. It also helps control better ach wires, a 2-factor authentication, and be able to give access to the clerk. The cost is \$35 a month per account.

Motion 5-205-Motion by Trustee Sisti, seconded by Trustee Koch to approve the Community Bank Positive Pay Platform-Fraud Protection on 4 fund accounts. Motion carried.

The Office of Comptroller did a tax cap review audit-there was no findings.

Budget Medication #7 was provided to the board for approval for General, Water and Sewer. As the end of the year is approaching the balancing of estimated allocations is necessary.
