Motion 2-136-Motion by Trustee Koch, seconded by Trustee Sheibley to approve the minutes from the January 14, 2025 board meeting. Motion carried.

Village elections will be March 18, 2025 from 12pm-9pm.

The Hollywood Theater agreement for the Village to do snow removal services only for the public parking lot at 34 West Main St was provided to the board for approval.

Motion 2-137-Motion by Trustee Nephew, seconded by Trustee Sheibley to approve the snow removal agreement with the Hollywood Theater-34 West Main St public parking lot. Motion approved.

The Village is need of a Zoning Board of Appeals. The Village needs 3 members with staggering terms.

Motion 2-138-Motion by Trustee Koch, seconded by Trustee Sheibley to approve Robert Tiller-3-year term, Barbara Nephew-2-year term and Rev. Travis Grubbs-1 year term to the Zoning Board of Appeals. Trustee Nephew abstained due to conflict. Motion carried.

Cattaraugus County DPW Correspondence RE: Crosswalks and signage.

- 4 Speed limit signs for Aldrich St near the elementary school have been ordered.
- Cross walk by the Theater-Adam reached out to the NYS traffic safety, who looked and given the location with parking on both sides, a parking lot, and a crosswalk within 250 feet on both sides of that location it does not qualify at this time.
- Crosswalk at St. Johns and College St.-Adam feels that a crosswalk would create additional hazards for children-maybe a stop sign is better suited for this.

Motion 2-143-Motion by Trustee Koch, seconded by Trustee Zimmermann to support the Hollywood Theater Liquor License renewal for 2025. Motion carried.

Motion 2-144-Motion by Trustee Sheibley, seconded by Trustee Nephew to approve the 2025-2026 Draft #1 Budget. Motion carried.

A funding agreement for LEWPA Flood Mitigation projects was provided to the board for approval for stabilization projects for Grannis Creek, Thatcher Brook and Allen Springs.

Motion 2-145-Motion by Trustee Koch, seconded by Trustee Zimmermann to approve the Cattaraugus County Soil & Water agreement for LEWPA flood mitigation. Motion carried.

The WWTP capital project pay app #2.

Motion 2-146-Motion by Trustee Zimmermann, seconded by Trustee Nephew to approve the WWTP pay app #2 to BECC Electric through 1/31/25 at \$59,280. Motion carried.

Motion 2-147-Motion by Trustee Koch, seconded by Trustee Sheibley to approve WWTP pay app #2 to Quakenbush Company through 1/3/25 at \$55,521.23. Motion carried.

Cattaraugus County youth services had some unclaimed funds that they thought the Village would use for expenses from 10/1/23-9/30/24. The Village spent \$12,900 on the Summer Recreation Program. The Village will be reimbursed that from the grant funds.

Motion 2-148-Motion by Trustee Sheibley. Seconded by Trustee Koch to accept the youth sports education funding for a total of \$14,900. Motion carried.

The annual budget for Peter Cooper was completed with the anticipated expenditures for 2025.

Motion 2-149-Motion by Trustee Koch, seconded by Trustee Sheibley to approve the authorization for Peter Cooper 2025 annual budget transfer of \$34,3263.23 to the OM & M Truste for anticipated operating expenses. Motion carried.

The Village had a NYMIR Risk Assessment done and recommendations were made for the Village to decrease liability. A response has been prepared to those recommendations.

Motion 2-150-Motion by Trustee Nephew, seconded by Trustee Koch to approve the NYMIR Risk Assessment recommendations response. Motion carried.

The employee's health insurance needs to be renewed with Independent Health.

Motion 2-151-Motion by Trustee Nephew, seconded by Trustee Sheibley to approve to renew health Coverage with Independent Health effective 6/1/25. Motion carried.

The abstract bills to pay #9 was provided to the board for approval.

Motion 2-152-Motion by Trustee Nephew, seconded by Trustee Zimmermann to approve the abstract bills to pay #9 for General at \$32,544.21, Water at \$6,898.20, Sewer at \$28,998.68, and Capital Projects at \$149,375.25. Motion carried.
